

Web and Mobile Privacy Policy

Our Privacy Policy is expressly incorporated into the Terms of Use and other agreements on this site by this reference. By continuing to use the Site and services and by providing your personal information to us, you agree to the practices and policies described in this Privacy Policy.

Information You Give Us

We collect your personal health information (PHI) such as name, email address, phone number, and credit card information for payment, only when you voluntarily give it to us to register for an account and subscribe to our Services.

We will not use any PHI for any other purpose without your written authorization, or unless otherwise permitted or required by law. You may revoke, in writing, any such authorization at any time, except to the extent we have taken action in reliance thereon.

We do not knowingly enroll directly or collect information directly from children under the age of 18.

If you contact us about our Site or services, we may retain the content of your email, your email address and our response to you. We retain this information for a period of time to resolve disputes, troubleshoot problems, or for other valid business or legal reasons.

Other Information We Collect

Images, videos, or audio recordings will only be collected from your device if you voluntarily select it to upload to the application to store or share with your Provider or other users within the Site. Multimedia will not be shared with other Site users without your consent (with the exception of your profile photo, to the extent such feature is offered, which will appear in your user profile).

We may use mobile application tracking and/or analytics services. These services may record unique mobile gestures such as tap, double-tap, zoom, pinch, scroll, swipe and tilt but do not collect personally identifiable information that you do not voluntarily enter in the Site. These services do not track your browsing habits across mobile applications that do not use the same services. We are using the information collected by these services to understand user behavior and optimize site performance.

Sharing of Information

We do not sell or rent your personal information to any other third party. We only share Personal Information with third parties who are bound by terms at least as restrictive as this Privacy Policy and only for the following reasons:

We share Personal information with third-party service providers who perform a variety of functions to enable us to provide our services. These service providers only have access to the Personal Information necessary to perform their

functions, only act on our behalf and under our instructions, and may not use this information for any other reasons aside to perform such functions.

We may disclose Personal information to courts, law enforcement agencies and other government bodies if we suspect that an individual's use of our Site or services involves illegal activity or is otherwise inconsistent with any applicable terms and conditions. We may also disclose Personal Information where we believe that doing so would be in accordance with or required by any applicable law, regulations, or legal process.

We may transfer any or all Personal information in the event of a corporate transaction, such as the sale of all or a portion of our business, a divestiture, merger, consolidation, or asset sale, or in the event of bankruptcy, as required or allowed by law.
